CHINA CENTER FOR HUMAN CAPITAL AND LABOR MARKET RESEARCH

Established in March 2008, the China Center for Human Capital and Labor Market Research (CHLR) at the Central University of Finance and Economics (CUFE) is part of a Special Platform for Advance Programs at the CUFE. It is an international research center for the study of human resources, labor markets, and their impact, focusing on China and related economies.

Nobel Laureates James Heckman, and Professor Dale W. Jorgenson of the Harvard University and the founder of the income-based method for measuring human capital, serve on the Advisory Board.

All faculty and research fellows of the CHLR hold a Ph.D. degree in economics from major universities in North America and Europe, and all visiting professors are tenured professors from major U.S. universities. Currently the Center has 5 full-time faculty members, 7 special term professors, and 11 senior research fellows. Among the teachers, there are 7 special term professors and 5 assistant professors.

The major research areas in the Center include but are not limited to human capital investment; its measurement and impact; education, health; innovation, entrepreneurship; and labor market outcomes and labor-related government policy.

The CHLR has master's, doctoral and post-doctoral programs. The Center's graduate programs are internationally oriented. The curriculum and instruction are rigorously designed following research universities in North America. All courses are taught in English.

中央财经大学

中国人力资本与劳动经济研究中心简介

中国人力资本与劳动经济研究中心（CHLR）（以下简称“中心”）隶属于中央财经大学“经济学与公共政策优势学科创新平台”，成立于 2008 年 3 月，是一个以研究中国人力资本、劳动力市场及其与经济发展关系为主要研究方向的院级国际化研究中心；中心招收博士后、博士和硕士研究生。中心顾问由该领域的国际著名教授担任，其中包括诺贝尔经济学奖得主 James Heckman 教授，以及人力资本计算方法——终身收入法创始人之一，哈佛大学的 Dale W. Jorgenson 教授。

中心的教学科研成员全部为北美知名高校的终身教授或者拥有北美或欧洲知名高校经济学博士学位的海归学者。中心有全职教师 5 人，特聘教授 7 人及特聘研究员 11 人。教师队伍中，特聘教授 7 人，助理教授 5 人。

中心以科研为主导，强调国际化的前沿学术研究。主要研究方向为：1) 人力资本的形成、度量及作用，2) 教育、健康与人力资本，3) 人力资本与创新及创业，4) 劳动力市场与政策，5) 人口与社会保障，6) 产业组织。

中心拥有科学完备的博士及硕士研究生培养方案，其课程体系和课程设置与美国研究类高校一致，采用全英文授课及国际化人才培养方式。截至 2018 年，中心已毕业博士后 1 人，博士生 8 人，硕士生 103 人。目前在校生 31 人，其中全日制硕士生 27 人，全日制博士生 4 人。

BRIEF INTRODUCTION TO THE CHINA'S HUMAN CAPITAL PROJECT

The research project, “China’s Human Capital: Measurement and Index Construction,” is conducted by the China Center for Human Capital and Labor Research Center (CHLR), and funded by the National Natural Science Foundation of China and the Central University of Finance and Economics. The project aims at establishing China’s first scientific and systematic human capital index, quantitatively describing China’s human capital distribution, trend and dynamics. It constructs important measurements for further evaluating human capital and its contribution to economic development and provides policy-makers with important information on the nation’s human capital development.

The project is part of the international effort to establish comparable national human capital measurement across nations and to eventually incorporate human capital into the National Income and Product Accounts (NIPA) system.

The project is led by Professor Haizheng Li. The research team includes Professor Barbara Fraumeni (a pioneer scholar in developing the Jorgenson-Fraumeni method of human capital calculation), other full-time and special-term professors, graduate students, and administrative staff at the CHLR. Since the inaugural issue of the China Human Capital Report in 2009, the project has generated great social impact, and has drawn the attention of academia and governments both at home and abroad.

The human capital measurements produced by this project have been widely used in research and policy analysis. The China human capital report series and the related data including the human capital estimates, processed data and raw data, are freely available to the public at <http://humancapital.cufe.edu.cn/>

中国人力资本指数项目简介

中国人力资本与劳动经济研究中心（以下简称“中心”）的“中国人力资本的测量及人力资本指标体系的构建”项目得到国家自然科学基金委员会连续九年的资助及中央财经大学的专项资助。该项目旨在建立中国第一套科学、系统的人力资本指数，定量描述中国人力资本的分布及发展动态；为更深入地研究人力资本在中国经济发展中的作用提供综合的度量指标；在实践上为政府的相关重大经济社会决策提供定量依据；同时也为中国的人力资本度量方法和指标成为国际人力资本指标体系的一部分、为人力资本作为国民账户的一部分纳入到我国国民财富的衡量体系提供前期工作。该项目由中心李海峥教授主持，由人力资本收入算法（Jorgenson-Fraumeni 方法）创始人之一的 Barbara Fraumeni 教授，中心全职教授和特聘教授，以及中心全体博士、硕士研究生及行政人员共同参与。

研究成果汇编成的《中国人力资本报告》自 2009 年公开发布以来，受到了国际、国内学术界及我国政府部门的高度重视，引起了广泛的、良好的社会反响。中国人力资本报告系列及历年的计算结果、中间数据、以及原始数据已经被广泛应用，相关资料及数据可以在人力资本中心官方网站下载，免费供社会各界使用（<http://humancapital.cufe.edu.cn/>）。

2009--The First International Symposium on Human Capital and Labor Markets

About the Symposium

On October 10, 2009, CHLR held its first international symposium on measurement of human capital and released the China Human Capital Report 2009. The Principle Investigator for the project, Prof. Haizheng Li presented the methodology of the estimation of human capital stock and the estimation results at the national level for 1985-2007. The China Human Capital Report 2009 establishes China's first systematic and comprehensive human capital measurement and human capital index, including the stock of human capital of China 1985-2007, by urban-rural and by gender; human capital per capita; various human capital indices; and the forecast of China's human capital stock for 2008-2020. The symposium included academic sessions focusing on the measurement of human capital, construction of the human capital index, and the contributions of human capital to economic growth and welfare.

Participants

Nobel Laureate Prof. Kenneth J. Arrow, Prof. Ken He (Deputy Director, Finance Committee of the Standing Committee of the National People's Congress), and Prof. Dale W. Jorgenson (co-founder of the Jorgenson-Fraumeni income-based method for measuring human capital, Harvard University), gave keynote speeches in the plenary session. Prof. Guangqian Wang (President of CUFU), Prof. Donggang Zhang (Deputy Director of the Social Science Division, Ministry of Education), Dr. Xianchun Xu (Deputy Commissioner, National Statistics Bureau), and Dr. Zhongjie Jia (Director of the Senior Civil Servants Training Center, Ministry of Human Resources and Social Security) also participated in the symposium. Over 800 domestic and foreign scholars including Professor Barbara M. Fraumeni (University of Southern Maine), national and international government officials, as well as university students, attended the symposium.

2010--The Second International Symposium on Human Capital and Labor Markets

About the Symposium

The Second International Symposium on Human Capital and Labor Markets and the release of the China Human Capital Report 2010 was held in Beijing October 15, 2010. The symposium was organized by the CHLR. In the meeting, the China Human Capital Index and Report 2010 were released. This year's report updates the human capital estimation at the national level; and for the first time, human capital at the provincial level is estimated. The 2010 report includes human capital estimation results for Beijing, Liaoning, Jiangsu, Guangdong, and Gansu.

Dr. Ardo Hansson (Chief Economist, World Bank China Office), Dr. Danling Zhao (Official of Ministry of Education), Prof. Yuetian Li (Deputy Director-General of Ministry of Human Resources and Social Security), and Prof. Guoqiang Long (Director-General, Research Department of Foreign Economic Relations, the State Council Research and Development Center) provided helpful comments on the human capital index report, as specially invited discussants. Prof. Barbara Fraumeni (a co-developer of the Jorgenson-Fraumeni method of human capital calculation) chaired the meeting, and Professor Haizheng Li presented new results from the Human Capital Report 2010. Additionally, officials from the Ministry of Education, National Development and Reform Commission, the National Bureau of Statistics, the Department of Organization of Beijing, and the

Development and Reform Commission of Shanghai, and other agencies, as well as domestic and foreign scholars attended the symposium.

2011--The Third International Symposium on Human Capital and Labor Markets

About the Symposium

The Third International Symposium on Human Capital and Labor Markets and the release of the China Human Capital Report 2011 was held in the Central University of Finance and Economics (CUFE) on October 28, 2011. The symposium was organized by the CHLR, and it released the China Human Capital Report 2011. Compared with previous human capital reports, the 2011 Report shows significant improvements in calculation methods, addresses the problem of missing data at the provincial level, and also adds new micro survey data. The Report updates the national human capital estimates for 1985-2009 and expands the coverage to 12 provinces (Beijing, Shanghai, Gansu, Guangdong, Jiangsu, Liaoning, Anhui, Shandong, Guizhou, Hubei, Hunan, and Henan). In addition, the Report discusses human capital across provinces and their trends and patterns.

Mr. Fengyun Lei (Deputy Director, State Administration of Foreign Experts Affairs), Prof. Barbara Fraumeni (a co-developer of the Jorgenson-Fraumeni method of human capital calculation), Prof. Yijun Li (Deputy Director, Division of Management Science, National Natural Science Foundation of China), Junsheng Li (Vice President, Central University of Finance and Economics), as well as other domestic and foreign scholars also attended the symposium.

2012--The Fourth International Symposium on Human Capital and Labor Markets

About the symposium

The Fourth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2012, organized by the CHLR was held in CUFE on December 14, 2012. The China human capital report 2012 was released. The new report uses updated provincial statistical data and computes human capital for five new provinces (Tianjin, Heilongjiang, Zhejiang, Guangxi and Shaanxi) in 1985-2009. The corresponding panel data of measures of human capital for 17 provinces was constructed. Various data of human capital were released online at the Center's website to promote sharing of research data.

Participants

Prof. Barbara Fraumeni (University of Southern Maine, a co-developer of the Jorgenson-Fraumeni method of human capital calculation) chaired the plenary session. The new human capital report was presented by Prof. Haizheng Li. As specially invited discussants and commentators, Prof. Weiping Li (the chief research fellow from the Chinese Academy of Personnel Science), Prof. Dennis Tao Yang (University of Virginia), and Prof. Yansui Yang (Tsinghua University), gave insightful comments on the Report. In the afternoon, the conference organized three academic sessions. Scholars from China and other countries discussed ongoing research related to broad issues of human capital and labor markets. Prof. Rachel Connelly (Bowdoin College), Prof. Zhenhui Xu (Georgia University and College), and Prof. Dennis Tao Yang chaired the academic sessions. Prof. Lifan Zhao (Vice President of CUFE) also attended the symposium.

2013--The Fifth International Symposium on Human Capital and Labor Markets

About the symposium

The Fifth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2013, organized by the CHLR was held in CUFE on December 15, 2013. The China human capital report 2013 was released. Updated national and provincial human capital used newly released 2010 census data. Estimated human capital for 5 new provinces in 1985-2010: Hainan, Jiangxi, Jilin, Sichuan, Chongqing. The corresponding panel data of gross measures of human capital for 22 provinces was constructed. The Report also contained estimates of the national and provincial physical capital stock and cross-provincial living cost.

There were 10 human capital-related parallel academic sessions in which there were 41 research papers selected from international and domestic submissions. Scholars from China and other countries discussed ongoing research related to broad issues of human capital and labor markets.

Prof. Barbara Fraumeni (University of Southern Maine, one of the founders of the Jorgenson-Fraumeni method of human capital calculation) chaired the plenary session. The new human capital report was presented by Prof. Haizheng Li. As special invited keynote speakers, Prof. Zhenghua Jiang (former vice chairman of the National People's Congress) and Prof. Mark R. Rosenzweig (Frank Altschul Professor of Economics, Yale University) gave keynote speeches. Dr. Vincent Perrin (OECD Beijing Representative), Prof. Belton M. Fleisher (Editor of China Economic Review & Ohio State University & CHLR), Prof. Guangqian Wang (president, CUFE), Prof. Junsheng Li (Vice President of CUFE), and Prof. Lifan Zhao (Vice President of CUFE) also attended the symposium.

2014--The Sixth International Symposium on Human Capital and Labor Markets

About the symposium

The sixth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2014, organized by the CHLR, was held in CUFE on October 31, 2014. The China human capital report 2014 was released. The Report included estimated human capital for 9 new provinces in 1985-2010: Shanxi, Qinghai, Inner Mongolia, Xinjiang, Tibet, Yunnan, Fujian, Hebei, Ningxia, Hong Kong and Taiwan; re-estimated human capital for Hainan province; estimated and national and provincial physical capital stock; and estimated cross-provincial living cost indices.

Participants

Jeffrey S. Zax (Professor, University of Colorado at Boulder) chaired the plenary session. Belton M. Fleisher (Professor, Ohio State University & Special-term Professor, CHLR & Editor, China Economic Review) gave a speech on "Remarks in Memory of Gary S. Becker." The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology & CHLR), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson-Fraumeni method of human capital calculation) and Carsten A. Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators included Shujie Han (Editorial Director, Journal of Human Resource Development of China), Martina Lubyova (Director, Institute for Forecasting, Slovak Academy of Sciences), Peter F. Orazem (Professor, Iowa State University) and Jeffrey S. Zax (Professor, University of Colorado at Boulder), who gave in-depth discussions on this year's Report. Prof. Junsheng Li (Vice President of CUFE) also attended.

We received 77 submissions, among which 32 were accepted for presentation.

2015--The Seventh International Symposium on Human Capital and Labor Markets

About the symposium

The seventh International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2015, organized by the CHLR was held in CUFU on December 12, 2015. The China human capital report 2015 was released. Human capital calculation for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) were extended to 1985-2012. There were some revisions and improvements in the 2015 Report, including updating the data for enrollment categorized by region and gender to 1985-2012, and adding China Family Panel Studies (CFPS2011) to estimate Mincer parameters. The China Human Capital Report 2015 also reported the average age of labor force, average education level and the proportion of population with high-school education. The news of establishing CPS (Complex Problem Solving) Test Lab in China by the CHLR was released during the symposium.

Belton M. Fleisher (Professor, Ohio State University & Special-term Professor, CHLR & Editor, China Economic Review) chaired the plenary session. The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology & CHLR), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson- Fraumeni method of human capital calculation) and Carsten A Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators: Gary Jefferson (Professor, Brandeis University), Scott D. Rozelle (Professor, Stanford University), Shi Li (Professor, Beijing Normal University) and Tao Xin (Professor, Beijing Normal University). Phil. Samuel Greiff (Associate Professor, University of Luxembourg), Kevin Murphy (Professor, Colorado State University) and Peer Ederer (Professor, Zeppelin University) participated in the releasing the news of establishing CPS (Complex Problem Solving). Jianfeng Peng (Professor, Renmin University & Chairman, China Stone) and Jianping Shi (Vice President of CUFU) also attended.

More than one hundred of international and domestic scholars attended the seventh human capital symposium. The symposium selected 40 papers out of 98 submissions, with 10 parallel sessions covering education, income, health, poverty and behavior, labor market, employment, immigration, human capital, children and complex skills.

2016--The Eighth International Symposium on Human Capital and Labor Markets

About the symposium

The eighth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2016, organized by the CHLR was held in CUFU on December 10, 2016. The China human capital report 2016 was released. Human capital calculation for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) has been extended to 1985-2014. There were some revisions and improvements in the 2016 Report, including updating the data on school enrollment by region and gender based on new data sources for 1985-2014, and estimating both national and provincial physical capital stock for 1985-. The China Human Capital Report 2016 also unified the population estimation method at the national and province level, and it included data on re-calculated national human capital.

Participants

Belton M. Fleisher (Professor, Ohio State University & Special-term Professor, CHLR & Editor, China Economic Review) chaired the plenary session. The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology & CHLR), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson- Fraumeni method of human capital calculation) and Carsten A. Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators, Min Tang (Ph. D, State Department Counselor & Vice President of YouChange China Social Entrepreneur

Foundation), Boqing Wang (Ph. D, Founder & Chair of MyCOS (China Occupational Skills)) gave in-depth discussions on this year's Report. Jianping Shi (Vice President of CUFE) also attended.

We received 122 submissions, among which 60 papers were accepted for presentation in 14 parallel sessions.

2017--The Ninth International Symposium on Human Capital and Labor Markets

About the symposium

The ninth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2017, organized by the CHLR was held in CUFE on December 9, 2017. The China human capital report 2017 was released. Human capital calculation for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) were extended to 1985-2015. There were some revisions and improvements in the 2017 Report, including updated population of 2015 for some provinces based on new information, adding CHIP 2013 and CFPS 2014 data in estimating the Mincer equations, and adjusting the method in imputing the coefficients for the experience variable in the Mincer equations. The China Human Capital Report 2017 also improved with a unified imputation method for 1982 and 1987 census data using new information.

The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology & CHLR), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson- Fraumeni method of human capital calculation) and Carsten A Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators, Junjie Hong (Dean, Professor, and Ph.D. advisor of School of International Economic and Trade in University of International Business and Economics), Weiguo Yang (Dean, Professor and PhD advisor of School of Labor and Human Resources, Renmin University of China) gave in-depth discussions on this year's Report.

We received 116 submissions, among which 37 papers were accepted for presentation in 9 parallel sessions, covering employment, education, labor market, cognition, health, income, and human capital.

历年人力资本发布会议回顾

一、第一届人力资本研讨会

1. 会议内容

2009年10月10日，中央财经大学中国人力资本与劳动经济研究中心举办了主题为“人力资本的度量及其对增长和福利的贡献”国际研讨会，首次发布中国国家层面人力资本指数及《中国人力资本报告2009》（中英文版）。项目负责人李海峥教授详细阐述了中国人力资本度量方法与相应的计算结果，以及中国人力资本度量项目的未来发展方向。

本项目探索性地建立了中国人力资本的综合度量体系，其阶段性成果包括：1985-2007年中国分城乡、分性别的名义与实际人力资本存量，相应人均人力资本与各种人力资本指数；人力资本分布状况和变化趋势；对2008-2020年中国人力资本水平的预测。

本次会议还组织了学术分会，分会主题包括人力资本度量方法、中国人力资本指数的构建、以及人力资本对经济增长和福利的贡献等。

2. 出席嘉宾

诺贝尔经济学奖获得者肯尼斯·阿罗(Kenneth Arrow)教授、全国人大常委财经委员会副主任贺铿教授、人力资本计算方法创始人哈佛大学的戴尔·乔根森(Dale Jorgenson)教授分别作大会主题发言。中央财经大学校长王广谦教授，教育部社科司副司长张东刚，国家统计局副局长许宪春，人力资源和社会保障部、中国高级公务员培训中心主任贾忠杰等以及其他海内外政府官员和学者出席了会议。来自海内外的专家学者、政府及国际组织官员、高校学生等八百多人参加了全体会议。

二、第二届人力资本研讨会

1. 会议内容

2010年10月15日，中央财经大学中国人力资本与劳动经济研究中心举办了“第二届中国人力资本指数发布暨人力资本研讨会”，本次会议发布了《中国人力资本报告2010》，内容包括：更新后的中国国家层面人力资本计算结果，并首次将中国人力资本的计算深入到省级层面，计算1985-2009年北京、甘肃、广东、江苏、辽宁五个省(市)的人力资本存量与指数。

2. 出席嘉宾

世界银行驻华首席经济学家 Ardo Hansson 博士，教育部人事司副巡视员赵丹玲、人力资源和社会保障部政策研究司副司长李月田、国务院发展研究中心对外经济研究部部长隆国强等应邀对人力资本报告进行点评。人力资本终生收入法的创始人之一 Barbara Fraumeni 教授

组织本次人力资本报告的发布和点评。此外，教育部、国家发改委、国务院发展研究中心、人力资源和社会保障部、财政部、科技部、国家统计局、北京市组织部、上海市发改委的领导及其他国内外专家学者出席本次会议。

三、第三届人力资本研讨会

1. 会议内容

2011年10月28日，中央财经大学中国人力资本与劳动经济研究中心组织召开了“第三届人力资本国际研讨会暨2011年中国人力资本报告发布会”，发布2011年中国人力资本指数和报告。与前两年的人力资本报告相比，《中国人力资本报告2011》大幅度改进了计算方法以弥补省级数据的缺失，同时增加了微观调查数据，更新了1985-2009年国家层面人力资本指数并将省级层面估算扩展到12个省份：包括北京、甘肃、广东、江苏、辽宁、上海、安徽、山东、贵州、湖北、湖南和河南，并对各省人力资本分布和动态发展情况做出分析。

四、第四届人力资本研讨会

2012年12月14日，中央财经大学中国人力资本与劳动经济研究中心举行“第四届人力资本国际研讨会暨2012年中国人力资本报告发布会”，发布《中国人力资本报告2012》。与2011年中国人力资本报告相比，2012年中国人力资本报告使用了更新后的省级宏观数据，增加了天津、黑龙江、浙江、广西壮族自治区和陕西5个省（自治区、直辖市）1985-2009年的省级层面人力资本的估算，完成了国家层面及17个省市的人力资本计算结果的更新，建立相应的人力资本综合度量体系及相应的面板数据。根据人力资本的计算结果，报告还初步分析了影响人力资本增长的因素、人力资本与退休年龄的关系、以及人力资本对经济增长的贡献等问题。同时，人力资本的各项度量指标数据开始通过中心的网站对外发布，促进学术资源的共享。

2013年12月15日，中央财经大学中国人力资本与劳动经济研究中心举行“第五届人力资本国际研讨会暨2013年中国人力资本报告发布会”，发布《中国人力资本报告2013》。与2012年中国人力资本报告相比，2013年中国人力资本报告使用2010年人口普查数据，将全国和各省人力资本更新至2010年；新增加计算了海南、江西、吉林、四川和重庆人力资本，基本构建形成中国国家层面及二十二个省级层面人力资本面板数据库；估算并发布全国以及各省1985-2010年固定资本存量；计算并发布各省1985-2010年生活成本调整指数。会议展示了部分基于《报告》中数据进行研究的学术成果，并总结了《报告》五年内取得的成果。

本次人力资本大会在以往的基础上扩大规模，增设十场关于人力资本与劳动经济研究领域的学术专题讨论会，会议从海内外投稿中遴选出41篇高水平论文，分别就人力资本、劳动力市场、教育、工资、医疗保健、人口流动及实验经济学领域的最新成果进行交流。

Brief Introductions

to the Specially Invited Speakers and Discussants

Keynote Speakers:

Benjamin F. Jones

Benjamin F. Jones is the Gordon and Llura Gund Family Professor of Entrepreneurship, Professor of Strategy, and the faculty director of the Kellogg Innovation and Entrepreneurship Initiative. His research focuses largely on technological progress, with recent work investigating the role of teamwork in innovation and the relationship between age and invention. Professor Jones also studies global economic development, including the roles of education, climate, and national leadership in explaining the wealth and poverty of nations. His research has appeared in journals such as *Science*, the *Quarterly Journal of Economics* and the *American Economic Review*. He has been profiled in media outlets such as the *Wall Street Journal*, the *Economist*, and *The New Yorker*. A former Rhodes Scholar, Professor Jones served in 2010-2011 as the senior economist for macroeconomics for the White House Council of Economic Advisers and earlier served in the U.S. Department of the Treasury. In 2011, he was awarded the Stanley Reiter Best Paper Award for the best academic article written by a Kellogg faculty member in the preceding four years. Professor Jones is a research associate of the National Bureau of Economic Research and a member of the Council on Foreign Relations.

Zhuo Adam Chen

Dr. Zhuo (Adam) Chen is Associate Professor, University of Georgia; Li Dak Sum Chair Professor in Health Economics and Co-Director, Centre for Health Economics, University of Nottingham Ningbo China; Incoming Chair of Regents Committee, the Chinese Economists Society. He earned his Ph.D. in Economics and M.S. in Statistics from the Iowa State University. Before Dr. Chen joined the University of Georgia, he was a senior health economist with the US Centers for Disease Control and Prevention (CDC). Dr. Chen's research has focused on health economics, applied health econometrics, China's labor market, health inequality, and social determinants of health in both China and United States. His works have been published in *Health Economics*, *Journal of Health Economics* among others. His current research interests also include economics of obesity, mental health, genomics, and economic evaluation. He is a recipient of the CDC Excellence in Social and Behavioral Science Research Award in 2013. He has served as a Board Director of the Chinese Economists Society (CES) in 2007-2008 and 2012-2013, President of CES

in 2017-2018, and he is incoming Chair of the Regents Committee (2019) of the CES. He led the efforts to found the China Health Policy and Management Society (CHPAMS) and served as the President of CHPAMS during 2016-2018. He served as the President of the Asian Pacific Islander Employees of CDC/ATSDR during 2014-2016, and he was awarded the Civilian Award of Excellence in Diversity by the Federal Asian Pacific American Council in 2016.

Gordon Liu

Prof. Gordon Liu, PhD., is a MOH Yangtze River Scholar in Economics, PKU BOYA Professor of Economics, Chair of the Academic Committee of the Peking University National School of Development, Vice Dean of the PKU Faculty of Economics and Management, and Director of the PKU China Center for Health Economic Research. Previously, he was a tenured full time faculty member in the PKU Guanghua School of Management; UNC Chapel Hill; and USC. He received the PhD in Economics at the CUNY Graduate Center, and he received post-doctoral training in health economics at Harvard University. Prof. Liu currently serves as the China-side organizer for the annual *US-China Health Dialogue Track II*, in collaboration with the National Committee for US-China Relations (NCUCR). He also sits on the China State Council Health Reform Advisory Commission; the UN "Sustainable Development and Solution Network" (SDSN) Leadership Council led by Jeffrey Sachs of Columbia University, and Co-Chairs the SDSN Health Thematic Group. He was the President of the Chinese Economists Society (CES), and the founding Chair of ISPOR Asian Pacific Consortium. Prof. Liu has served as Associate Editor for the academic journals *Health Economics* (HE), *Value in Health* (The ISPOR official journal), and *China Economic Quarterly* (CEQ). His research areas include health and development economics, health reform, and health technology assessment. His recent book (co-edited with Robert Burns at Wharton) is "*China's Healthcare System and Reform*" published by Cambridge Press, 2017.

Invited Plenary Session Speakers:

Suqin Ge

Suqin Ge is an Associate Professor of Economics at Virginia Tech. She obtained her Master's degree in Economics from Fudan University in China and her Ph.D. from the University of Minnesota in the United States. Professor Ge's research focuses primarily on labor economics and the Chinese economy. Her work has covered a wide range of topics including education, labor supply, wage structure, discrimination, and migration. She has published journals including *Journal of Labor Economics*, *Journal of the European Economic Association*, and the *Journal of Applied Econometrics*. She was awarded U.S. Department of Labor Scholar in 2015.

Gary H. Jefferson

Gary H. Jefferson, Professor of Economics at Brandeis University, is a specialist in the Chinese economy, his research interests encompassing the economics of innovation, economic development and growth, and institutional economics. A former Fulbright Scholar at Wuhan University and visitor at the Center for Chinese Economic Research (CCER) at Peking University and Fudan University, Professor Jefferson works extensively with Chinese research colleagues. His collaborations in China include the Ministry of Science and Technology, the National Bureau of Statistics, and the Chinese Academy of Social Sciences. He has also consulted extensively with the World Bank on matters relating to enterprise reform and industrial policy. Professor Jefferson's work presently focuses on the returns to R&D spending and patenting. His research also explores the nature of technical change and growth theory. Along with publications in the *Journal of Economic Perspectives*, the *American Economic Review*, the *Review of Economics and Statistics*, the *Journal of Development Economics*, and the *Brookings Papers on Economic Activity*, Jefferson's recent work includes "Restructuring China's Research Institutes: Impacts on China's Research Orientation and Productivity," (*Economics of Transition*), "The Role of Research and Ownership Collaboration in Generating Patent Quality: China-U.S comparisons," (Brandeis Working Paper), and "Technology and Growth in a Fixed Physical World" (SSRN). At Brandeis, Professor Jefferson has served as Chair of the Economics Department and as Chair of the East Asian Studies Program.

Jong-Wha Lee

Jong-Wha Lee is a professor of economics and director of the Asiatic Research Institute at Korea University. He served as a senior adviser for international economic affairs to former President of the Republic of Korea. He was also previously Chief Economist and Head of the Office of Regional Economic Integration at the Asian Development Bank and an economist at the International Monetary Fund. He has taught at Harvard University and Peking University. He has published extensively on topics relating to human capital, growth, financial crises, and economic integration in leading academic journals. His most recent books include *Is this the Asian Century?* (World Scientific, 2017), *Crisis and Recovery: Learning from the Asian Experience* (World Scientific, 2016), *Education Matters: Global Schooling Gains from the 19th to the 21st Century*, coauthored with R. J. Barro (Oxford University Press, 2015) and *Rebalancing for Sustainable Growth: Asia's Postcrisis Challenge*, co-edited with M. Kawai (Springer, 2015). He is a regular columnist for Project Syndicate and Korea JoongAng Daily. He received the Chung-Ram Award (best young Korean economist) in 1997, Mae-Kyung Economist Award in 1997, and Dasan Economics Award in 2015. He obtained his Ph.D. and Master's degree in Economics from Harvard University.

Mary O'Mahony

Mary O'Mahony is Professor of Applied Economics, King's College London. Her research interests include measuring and explaining international differences in productivity, technology and

growth; human capital formation and its impacts on productivity and measuring performance in public services, including health and education. She is a researcher with the Economic Statistics Center of Excellence (ESCOE), which is a collaboration with the Office for National Statistics of the United Kingdom. She is also currently a visiting fellow at the National Institute of Economic and Social Research (NIESR) in London and she is a research associate at ZEW, Mannheim, Germany.

Scott Rozelle

Scott Rozelle holds the Helen Farnsworth Endowed Professorship at Stanford University and is Senior Fellow and Professor in the Freeman Spogli Institute (FSI) for International Studies. He received his PhD in economics from Cornell University, and has long specialized in research stemming from his interest in agricultural economics and China in particular. Scott was introduced to agricultural economics by his father, a California rancher and an agricultural economist who owned a commercial agribusiness magazine. He studied Chinese starting in junior high school in 1966, at the age of 12. While an undergraduate at Cornell, Scott's 3-month student-exchange visit to Taiwan grew into a 3-year stay. Since 1995, he has been an associate and friend of Dr. Jikun Huang, currently Professor, School of Advanced Agricultural Sciences, Peking University and Director, China Center for Agricultural Policy, Peking University.

Dr. Rozelle's current research focuses on the economics of poverty—with an emphasis on the economics of education and health. Dr. Rozelle is the co-director of the Rural Education Action Project (REAP) and is an adjunct professor in 8 Chinese universities. In 2008, Dr. Rozelle was awarded the Friendship Award—the highest honor that can be endowed on a foreign citizen—by Premiere Wen Jiabao.

Le Wang

Le Wang is Chong K. Liew Chair in Economics and Professor of Economics at the University of Oklahoma (OU), as well as a research fellow at IZA, Germany, and a special-term professor at Jinan University, China. He also serves as an Associate Editor of *Econometric Reviews*, *Journal of Labor Research*, and *China Economic Review*, as well as director of Young Scholars Program of the Global Labor Organization (GLO). Le's research focuses on questions in Econometrics and the subfields of microeconomics – Labor and Demographic Economics, Development Economics, and Public Economics. His work has been published in journals such as *Journal of Political Economy*, *Journal of Econometrics*, *Journal of Applied Econometrics*, *Journal of Environmental Economics and Management*.

Brief Introduction of Virtual Special Issue of China Economic Review

As stated in the Conference CFP, we plan a Special Issue of China Economic Review for papers from the 10th Annual Human Capital Conference. Guest Editors will be Zhiqiang Liu and Xiaojun Wang. We think that you will be very interested to learn that there has been a very important change in the publication process that vastly speeds up the time from submission until Accepted papers appear in print. In the past, after going through the standard double-blind review process, accepted papers were available online but were not published in hard copy until ALL the papers that were accepted were ready to be published. This could sometimes take a couple of years, and for those faculty in Chinese institutions, this delay sometimes affected their promotions.

Now there's a different system, called Virtual Special Issue (VSI), where in each paper Accepted for publication is published in the next hard copy of China Economic Review and at the same time is available in an online VSI for the Conference along with an introduction to the VSI and other relevant information. So there should be no longer by unnecessary delay in authors getting full credit for Accepted papers.

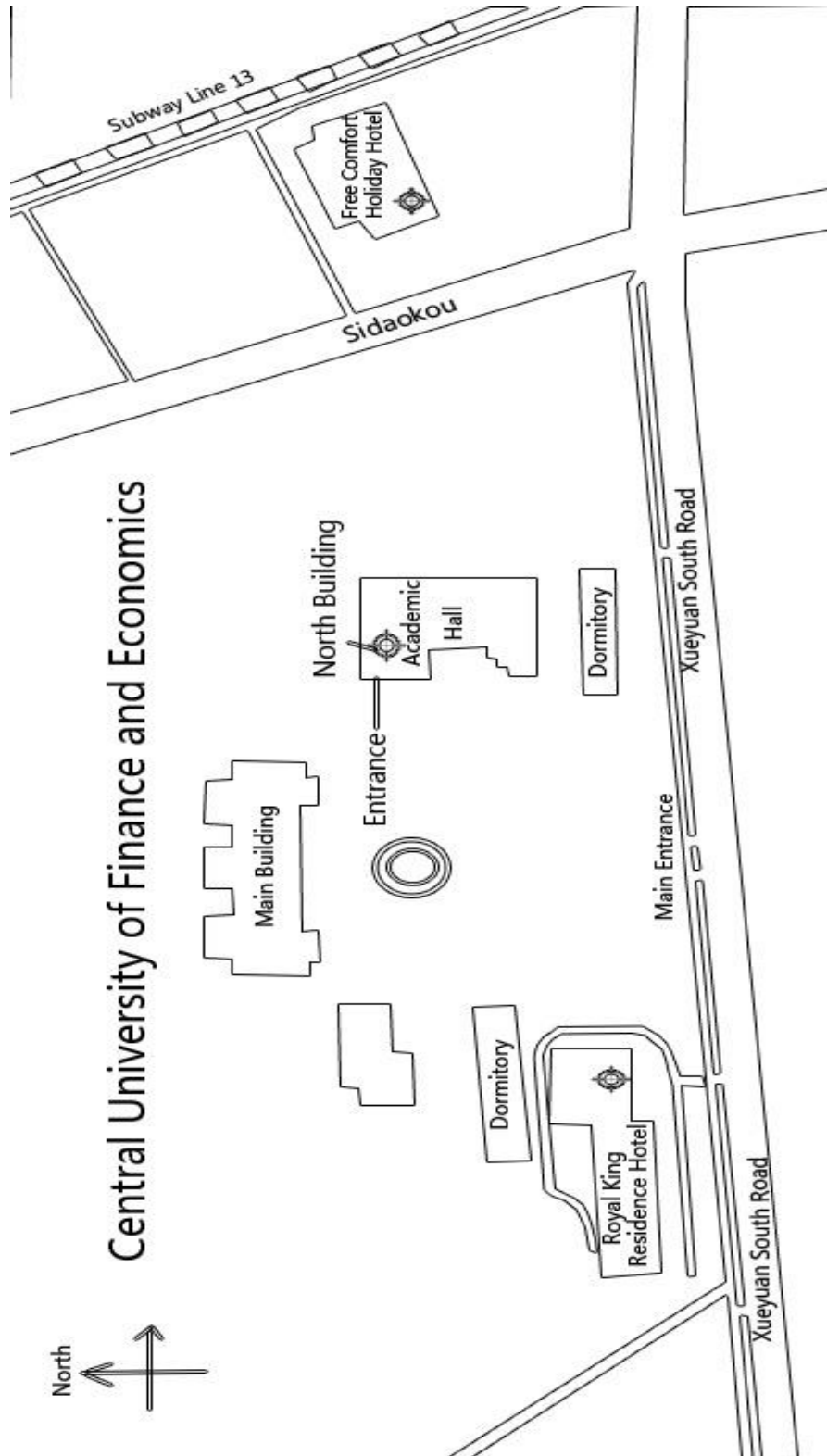

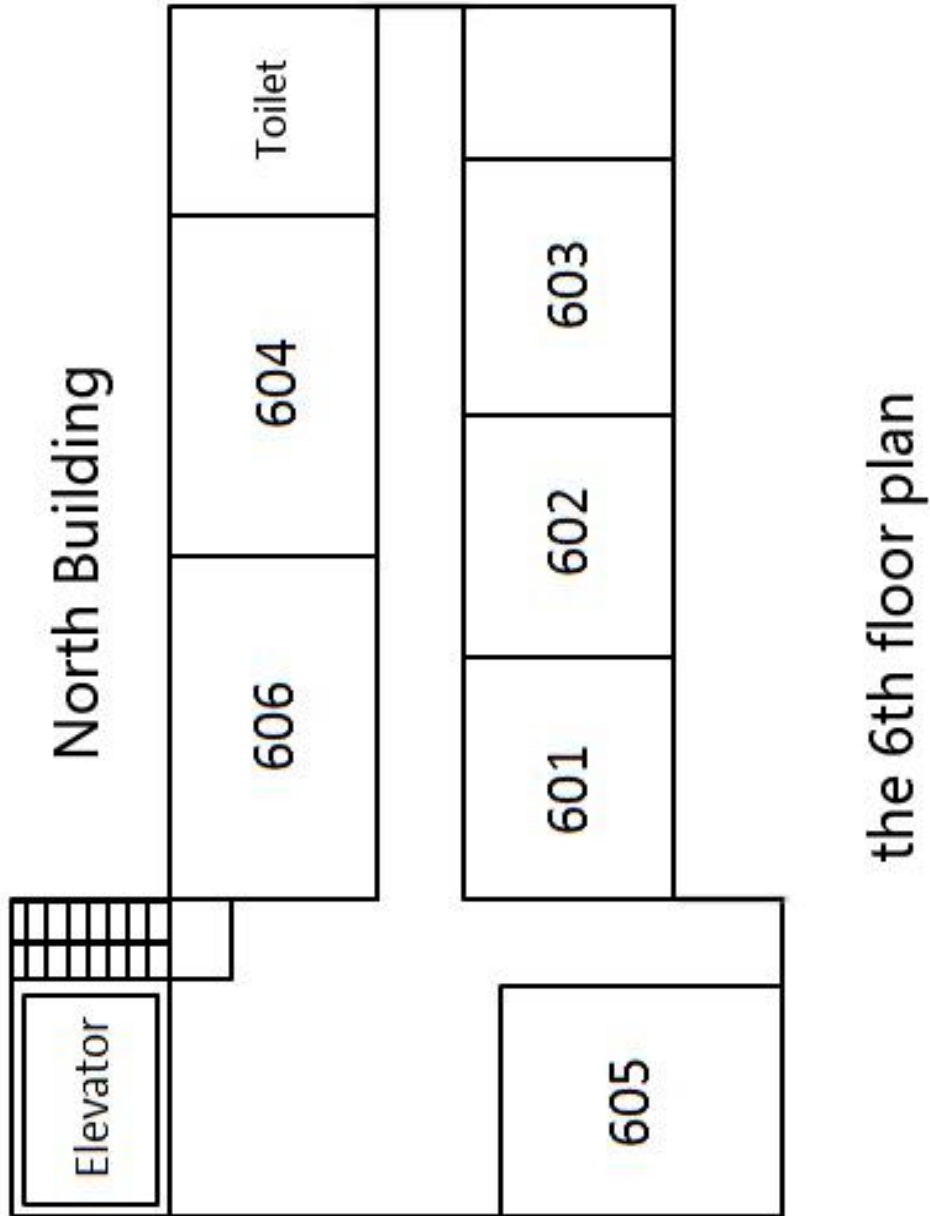

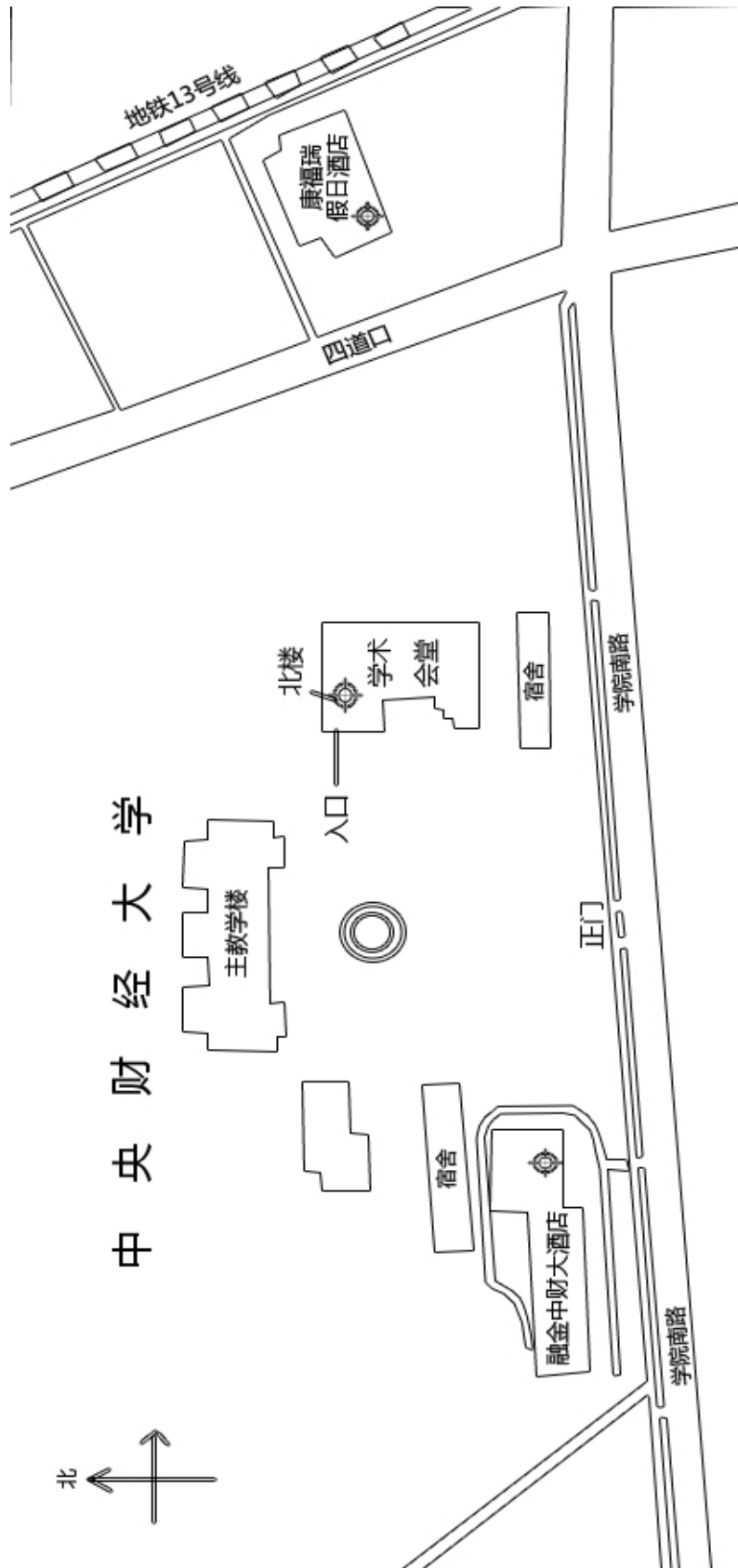
