中美貿易談判進入最後的關鍵時刻,美國貿易代表萊特希澤向參議院委員會稱,中美在技術轉移和知識產權議題已進行「周密的討論」,接近達成貿易協議。市場憧憬中美貿易談判快將有成果,人大上周五閉幕,國務院總理李克强在中外記者會上强調經濟增速維持合理區間,落實减稅降費。中港股市造好。上周港股出現强勁反彈,並重回 29,000 點收市。恒生指數全周波幅爲 28,240-29,204 點,於周五高見 29,204 點,收報 29,012 點。另外,英國國會下議院否决硬脫歐方案後,英國下議院以 412 票 贊成 202 票反對的結果通過了特裏莎•梅的動議要求推遲脫歐時間。關於英國脫歐的消息,亦需注意會否影響全球股市。上周中國平安(02318)及友邦保險(01299)分別已公布業績。中國平安(02318)業績較預期佳,股價持續有好表現。而本周業績焦點將會是騰訊控股(00700)、舜宇光學科技(02382)、小米集團 - W(01810)及長和系。美國聯儲局將於當地時間周二與周三將一連兩日進行議息會議,市場預期息率保持不變,關注會後記者會對未來息口及縮表步伐的預測。
